
1.) IGC Inside

General Assembly, May 21st, Vienna

On May 21st, IGC held its general assembly in Vienna. Our warm thanks go to Rita Niedermayr, who organized an absolutely great meeting. 39 participants - representing 25 member organizations – enjoyed the hospitality in Vienna. The agenda included inspiring presentations, in particular the recognition and adoption of the IGC standards. The annual meeting gave attendees a great opportunity to discuss current challenges and the future of controlling.

The meeting brought great presentations that addressed current challenges, such as rising commodity and energy prices, as well as long-term challenges, such as sustainable management or mastering uncertainty through an agile controlling organization. We would especially like to thank Mladen Meter (Business Effectiveness Ltd.), Tomasz Zieliński (Akademia Controllingu Sp. z o.o.), Lisa M. Beaudoin (IMA) and Frederic Doche (DFCG International) who gave insights into the current state of controllers' tasks and controlling processes in their regions/countries.

CEN Norm Controlling Profession

At the annual meeting, Giorgio Cinciripini and Alain Mulder proposed starting the process of a CEN norm for the controlling profession in collaboration with UNI. Giorgio Cinciripini explained the necessary steps and cost. IGC's management board discussed the proposal at its board meeting on July 10. The board decided to ask IGC members if they will engage because the idea was already presented at the General Assembly in Gdansk. At that time there was no support from the members. Therefore, we ask again who would get involved and work on the project. If there is enough support we would start the project. You can find the details in the attachment.

We are happy to provide two interviews. The first interview is **Alfred Biel's** 100th interview in the Controller Magazine. He interviews IGC **chairman Heimo Losbichler** about the impact of ICV on Controlling. The second interview was conducted by IGC board member **Rita Niedermayr**. She interviews **Gunther Reimoser**, Country Managing Partner of EY Austria, who has been advising national and international companies on holistic transformation projects for more than 20 years, and em.o. **Univ.-Prof. Dr. Christoph Badelt**, long-time Rector of the Vienna University of Economics and Business Administration and Director of the Austrian Institute of Economic Research (WIFO) until 2021 about fundamental change, sustainability, the status quo of digitalization and how the world of work can keep up with it.

3.) Trends and Studies - Internal Carbon Pricing

Apart from the sharp increase in the cost of raw materials and energy, the climate crisis and thus the question of sustainable management is currently THE topic in controlling. An essential question that controllers have to answer is the consideration of environmental costs, especially carbon emissions. The white paper "Internal Carbon Pricing - How to Operationalize, Measure and Control Carbon Emissions" by IGC board member Prof. Klaus Möller, Jan Schatzmann and Jasmin Schmid provides a comprehensive framework for designing ICP by analyzing, understanding, and applying ICP contingent to the company specific environment. 4.) Articles

In today's uncertain and fast changing environment agility is key. The article "Agility: The underestimated Enabler in the Transformation of the Controller Role" by Jochen Fellhauer and Andreas Ziegler, SAP shows that agile concepts can be an important success factor for controlling organizations for digitalization and the associated change in the controller's role. The authors use the example of the transformation of Controlling at SAP to describe how agile principles added value in controlling. (members only)
